RE: Michigan's Draft Statewide Transition Plan for Home and Community-Based Settings

The Michigan Department of Community Health (MDCH) provides Home and Community-Based Services to individuals served by Medicaid. These services support Michigan citizens with disabilities or other health issues to live in the community, rather than in institutions. The Department offers many of these services through "waivers," which are approved by the Centers for Medicare and Medicaid Services.

The Centers for Medicare and Medicaid Services recently released a new rule for Home and Community-Based Services waivers. The new rule, known as CMS 2249-F/2296-F, establishes requirements for Home and Community-Based settings under the §1915(c), §1915(i), and §1915(k) Medicaid authorities. The purpose of this rule is to improve the experience of individuals in these waiver programs by promoting greater access and integration with the community. MDCH has five §1915(c) waivers that are impacted by the new rule. They are:

- Children's Waiver Program
- Habilitation Supports Waiver
- MI Choice Waiver
- MI Health Link Program
- Waiver for Children with Serious Emotional Disturbance

The Michigan Department of Community Health developed a draft statewide transition plan for bringing these waivers into compliance with the new rule. Please note that the MI Health Link program is not included in the statewide transition plan. Because the §1915(c) waiver for the MI Health Link program is a new waiver, the MI Health Link waiver must be in immediate compliance with the final rule.

Discussion regarding evidence that a particular setting is "home and community-based" and/or similar comments will not be considered. Please limit your comments to the content of the draft plan.

The Michigan Department of Community Health will submit the final version of these documents to the Centers for Medicare and Medicaid Services for approval on January 16, 2015. At that time, the final version of these documents will be posted online.

There is no public hearing scheduled for the draft transition plan.
